Pie Funds Management Scheme: Pie KiwiSaver Conservative Fund

Fund update for the quarter ended: 30.06.24

This fund update was first made publicly available on 17.07.24

What is the purpose of this update?

This document tells you how the Pie KiwiSaver Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (**Pie Funds**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Pie KiwiSaver Conservative Fund seeks to preserve members' capital with modest capital growth over a period exceeding 3 years. The Fund invests primarily in fixed interest and cash, with an allocation to equities, directly and/or through investment in the Pie KiwiSaver Balanced fund and/or through other funds also managed by Pie Funds.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

What fees are investors charged?

Investors in the Pie KiwiSaver Conservative Fund are charged fund charges. In the year to 31 March 2024, these were:

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds, although these are not currently charged by Pie Funds).

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Lucy had \$35,000* in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a gain after fund charges were deducted of \$2,833 (that is 8.09%** of her initial \$35,000). Lucy did not pay any other charges. This gives Lucy a total gain after tax of \$2,305 for the year.

*This figure has been used as it represents close to the average contributing KiwiSaver Scheme member's balance in 2022 (estimate provided by FMA).

**This is the percentage return after duducting the total fund flat fee of \$240 p.a. Fee based on fund balance of \$35,000.

What does the fund invest in?

This shows the types of assets that the fund invests in.²



Hedging: We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure (as a percentage of total foreign currency exposure of the fund) is 81.65% (unhedged 18.35%).
